**Brilliance**<sup>™</sup> is a safe and effective long-lasting soil surfactant designed for use on fine turfgrass. Once in the rootzone, **Brilliance** alleviates soil water repellency, the cause of localized dry spot (LDS). **Brilliance** enhances the infiltration and overall movement of water in the rootzone to provide enhanced turf performance.

## FIRST AID MEASURES IN CASE OF CONTACT

**Brilliance** is readily soluble in water and can be applied with conventional application equipment. Apply **Brilliance** early in the season prior to the onset of stress. Do not apply **Brilliance** to turf under stress.

One full-rate application of *Brilliance* will provide 3 to 4 months of relief from water repellency problems such as LDS. The number of applications required is directly related to the length of the growing season, environmental and geographic conditions. Consult with your sales representative for the specific recommendation in your geographic location.

# DIRECTIONS FOR USE GENERAL TURF Greens, Tees, Fairways, Lawns and Sports Turf

*Full-Rate Application:* Apply *Brilliance* at 16 fl.oz./1,000 ft<sup>2</sup> (475 mL/93 m<sup>2</sup>) in 5 gallons (19 L) of water. Irrigation is required after each application in sufficient amounts to remove *Brilliance* from leaf surfaces. Reapply after 3 to 4 months or as necessary.

**Split Application:** Apply 8 fl.oz./1,000 ft<sup>2</sup> (240 mL/93 m<sup>2</sup>) in 2 gallons (7.5 L) of water. Follow up with second applications of 8 fl.oz./1,000 ft<sup>2</sup> (240 mL/93 m<sup>2</sup>) 7-10 days later. Irrigation is required after each application in sufficient amounts to remove **Brilliance** from leaf surfaces. Reapply after 3 months as necessary.

**Brilliance** is intended for use only as a single component in a spray application. Any combination of **Brilliance** with other substances in a spray application shall be at the Buyer/User's sole risk and shall be consistent will all manufacturers' label requirements.
